

What is Self-Advocacy?

Self-Advocacy is learning how to speak up for yourself, making your own decisions about your own life, learning how to get information so that you can understand things that are of interest to you, finding out who will support you in your journey, knowing your rights and responsibilities, problem solving, listening and learning, reaching out to others when you need help and friendship, and learning about self-determination. - Wrightslaw

Why is Self-Advocacy Important?

Leadership Opportunities

ADA Public Right-of-Way Citizen Advisory Committee

Snohomish County's ADA Public Right-of-Way (ADAPROW) Citizen Advisory Committee members are volunteers appointed by the County Engineer who help develop guidelines and recommendations to handle ADA compliance issues for pedestrian facilities in the public right-of-way. In August 2016 the Snohomish County Public Works performed a 'Self-evaluation' to identify barriers for individuals with disabilities.

<u>What is a Self-Evaluation?</u> State and local governments like Snohomish County build roads and sidewalks, operate and maintain traffic signals, and provide community programs, recreational activities, and facilities. They also operate airports and public transportation, maintain parks, and do so much more. In all that they do, government agencies must ensure that individuals with disabilities can participate and benefit from all their programs and services. A self-evaluation is an opportunity for a government agency to review all that it does and identify modifications that are needed so that individuals with disabilities can participate in civic life. Not only should government agencies conduct self-evaluations because they are the right thing to do, they are also required by the Americans with Disabilities Act (ADA) of 1190 (1).
